2. If structural failure should occur, and in the event that the consumer claims that there is a defect which is covered by this written warranty or any implied warranty

not disclaimed herein, the consumer is limited to the following damages:

- (a.) The liabilities of the manufacturer shall be limited to the original MANUFACTURER'S wholesale price of "THE REFUGE" only, and shall not include cost of removal, shipping, reinstallation, or any other costs not specifically expressed herein. Installation NOT included in this warranty.
- 3. This warranty extends exclusively to the original retail purchaser of the warranted product, and subsequent purchasers are not covered by this warranty agreement.

4. In the event of a structural defect not caused by any misuse or damage to the product while in the possession of the consumer, the warrantor will remedy the failure or defect, without charge to the consumer within a reasonable amount of time within which the obligation will be performed. The remedy will consist of repair of the product, or refund of the MANUFACTURER'S wholesale price, at the warrantor's option.

The product or "THE REFUGE" is not warranted against failures caused by improper installation, by excessive weight being placed within a ten foot perimeter of where "THE REFUGE" is installed or buried, by heavy equipment, tractors, or riding lawn mowers being operated, stored, or placed within a ten foot perimeter above where "THE REFUGE" is installed or buried, by damage caused by forces of nature or acts of God, or by damage caused by any excessive force applied to the ground service immediately above or within a ten feet perimeter of the location where "THE REFUGE" is installed or buried. This unit is NOT covered if, and in case of:
 - (a) Abuse of the product, accident, alteration, modification, tampering, negligence, misuse, faulty installation, and lack of reasonable care.
 - (b) If the installation instruction sheet provided by FIBERGLASS CREATIONS, INC., is not signed and dated by the installer.
 - (c) If the precaution sheet that is provided with this unit is not signed and dated by purchaser.

In the event that the product is not installed within six months of the date of purchase, the warranty shall begin upon the date of purchase.

As the Purchaser and Owner of "THE REFUGE," Underground Fiberglass Tornado Shelter, I/We understand that I/We will:

- (A.) NOT store any flammable liquids, fuels, incendiary devices, or explosives inside the shelter;
 - (B.) NOT use an open flame in any capacity (no lanterns, no cooking equipment, no heating elements, or other devices which burn fuel or have an open flame) inside the shelter;
 - (C.) NOT use any fume emitting equipment in the shelter or any other device which emits any toxic fumes, odors, poisonous gases, carbon monoxide, or other harmful or noxious gases;
 - (D.) NOT attach anything to the inside of shelter walls or cause holes to be drilled or cut in the walls, ceiling, or floor of the shelter. (In the event that any holes are drilled, cut or otherwise caused through the use or misuse of "THE REFUGE" to the ceiling, walls, or floor, I/We, understand that the Limited Warranty shall be of no further force or effect);

- (E.) NOT operate heavy equipment, riding lawnmowers, tractors, automobiles, or any other equipment of a weight of greater than 250 lbs. above the location of installation of "THE REFUGE" or within ten feet perimeter of where "THE REFUGE" is installed and buried;
- (F.) NOT store any items of more than 250 lbs. above the location where the shelter "THE REFUGE" is installed and buried or within a ten foot perimeter surrounding the location where "THE REFUGE" is installed and buried;

 - (P.) Notify any subsequent owners of "THE REFUGE" and all persons who shall use "THE REFUGE" of the contents of this Precaution Disclaimer form.

The REFUGE Storm Shelter

General Information on Care and Usage of your Shelter:

It is recommended that you routinely practice a home escape and shelter entry plan, so that you and your family will be comfortable with the usage of your shelter in the event of severe weather/warnings.

When necessary, you may clean the inside of your shelter with a damp cloth, but always wipe surfaces completely dry with a dry cloth or towel after cleaning.

Once or twice each year, you may want to spray silicone lubricant (found at auto parts stores) on the rubber door seal to prevent: dryness and cracking.

Underground SHELTERS MAY SWEAT:

It is possible that sweating may occur until the inside temperature and temperature of the ground are in balance. Conditions for sweating due to condensation in certain climates and seasons are favorable. However, the interior finish is easy to clean with a damp cloth, followed by a dry towel.
